

## Land Fill Subsidy Scheme Policy

### Objectives

- To attract and develop a broad range of social, cultural and economic entities.
- To encourage and assist community organisations to develop services and facilities that benefit the community.

### Policy Statement

To provide subsidised waste disposal facilities for eligible charitable or benevolent community based organisations within the City of Albany.

#### A. Eligibility

Bona-fide charitable or benevolent organisations providing economic, social, community or environmental services and benefits to the citizens of the City of Albany.

#### B. Applications

Applications must be submitted in writing addressed to the Chief Executive Officer and should include information verifying eligibility and details of expected waste types, volumes and regularity of disposal.

#### C. Delegated Authority

Authority is delegated to the Chief Executive Officer to determine eligibility of organisations to qualify for the Waste Services Subsidy in accordance delegation 2017:009 – Grant Funding, Donations, Sponsorship.

### Scope

The subsidy is only available specifically for waste that has already had all reusable materials removed i.e. recyclables and green waste. The scheme is to offset landfill charges only and is not to offset each organisation's responsibility to minimise waste going to landfill.
